Is Recreational Marijuana Legal in Florida? Simply put, recreational marijuana is illegal in Florida. According to Florida Statutes, 775.082 and 775.083, possession or sale without remuneration of 20 grams or less of cannabis is a misdemeanor offense with a penalty of up to one year in prison and carries a maximum fine of \$1000. Possession of paraphernalia is also a misdemeanor with the same maximum sentence.
